# A-LA-CARTE RATES

- Bridal Makeup..... \$375
- Bridal Makeup Trial..... \$200
- Mother of the Bride/Groom..... \$150
- Bridesmaid Makeup..... \$165

**ALL MAKEUP APPLICATIONS INCLUDE FALSE LASHES.**

All makeup services for members of the bridal party are a-la-carte, but PACKAGES are available exclusively for BRIDES.

Packages include things like travel, trial, day-of wedding makeup, plus bridal shower makeup as well!

# TRAVEL

Travel fees will be quoted upon inquiry.

Travel fees (drivable distances) apply to all bridal parties requiring on-site hair & makeup. (Deluxe Bridal Package includes travel fee for CT residents.)

## FLAT-RATE TRAVEL FEES:

- 0-50 MILES - \$150
- 50-90 MILES - \$175
- 90 - 125 MILES - \$225
- 

THE FULL DAY RATE LISTED ON PAGE 5 WILL BE APPLIED PER-DAY FOR ANY TRAVEL REQUIRING AIRFARE OR OVERNIGHT STAYS FOR THE DURATION OF TRAVEL TO AND FROM THE SERVICES BEING PROVIDED.

CLIENT WILL ALSO BE RESPONSIBLE FOR AIRFARE + NECESSARY TRANSPORTATION FEES INCURRED DURING TRAVEL TO + FROM THE SERVICE DESTINATION.

# DAY RATES

Worry about partying so hard you're gonna sweat your glam off - or are you changing into a second dress that you'd want a second makeup look for?

Do you just need a glam bestie to stay on-site to make sure you look like a STAR all night?

Or maybe you have a large bridal party and need more than one artist?

## FULL DAY

**FULL Day: + \$850**

I will stay for 6 hours after getting you ready for additional touchups/assistance.

## HALF-DAY

**HALF Day: + \$650**

I will stay for 3 hours after getting you ready for additional touchups/assistance.

## EXTRA ARTIST

**+ \$350**

This is an added-on fee for any bridal parties who are large in size with a smaller window of "getting ready time"

(EX: 3 hours of time with 10 people - we'll need roughly about 45 minutes per person)

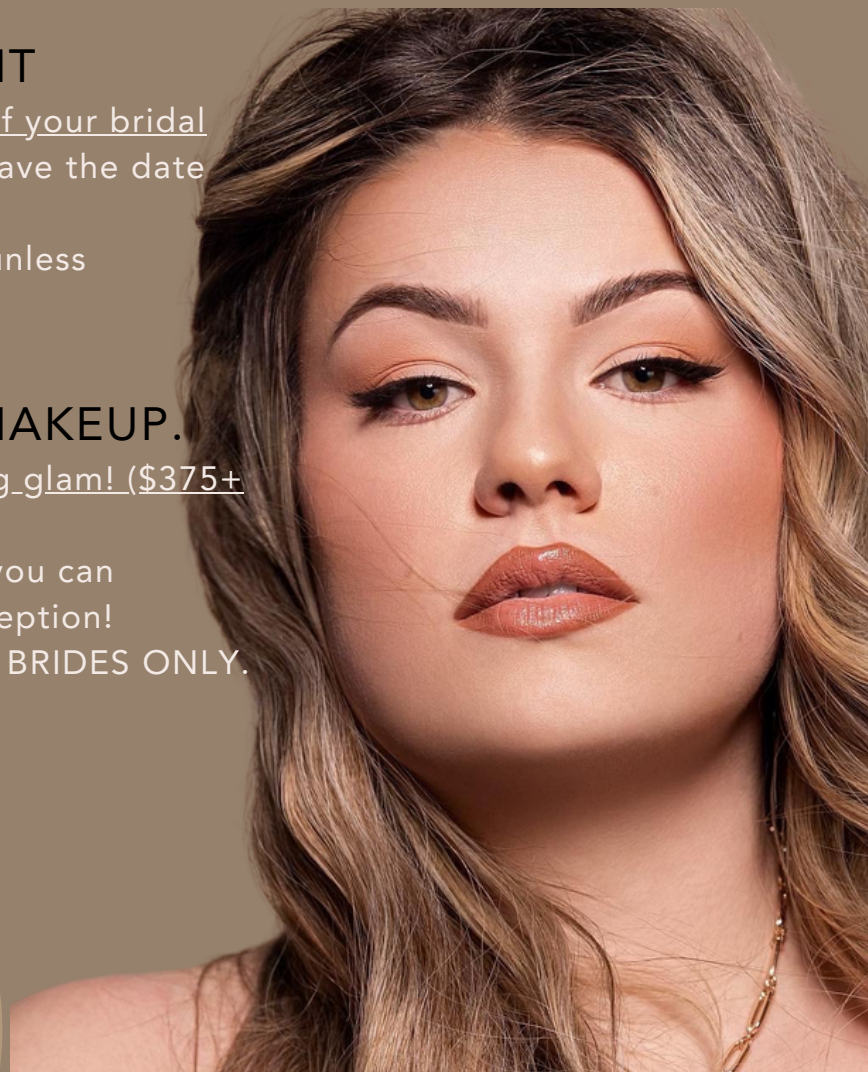
- This package includes makeup for one of your bridal events (\$165+ value) like your shower, save the date photos, Jack & Jill, etc!

- Travel is included for this event FOR CT BRIDES ONLY. (\$150+ value)

# FORMS OF PAYMENT ACCEPTED

## Accepted Payment Types

**I DO NOT ACCEPT VENMO OR CASHAPP FOR  
WEDDING BALANCES.**

ALL payments can be made in the following format-

- CASH
  - CREDIT/DEBIT  
BY EMAILED INVOICE (USING CARD, BANK TRANSFER)
- ALL PAYMENTS ARE DUE EITHER BEFORE OR ON THE DAY OF  
YOUR WEDDING.

## TRIALS

- If you book ONLY a trial with me, and NOT your wedding day makeup, **I cannot hold your wedding date.** I work on a first come first serve basis, so - if you have a trial scheduled with me and someone puts a deposit down on your desired date before you do- I have to give it to the person who is deposit-ready.
- **Trials are NOT included with a-la-carte bridal rates.** Trials must be booked separately from a-la-carte bridal makeup, or with a package.
- **I DO NOT PERFORM TRIALS ON ANYONE BUT THE BRIDE.** If MOB/G require a trial for special circumstances (has pigmentation issues, never wears makeup, etc), I will make an exception.
- I do not offer trials for Bridesmaids.
- **IF YOU NEED TRAVEL FOR YOUR TRIAL IT WILL BE ADDED** - travel is not automatically included for trials booked either a-la-carte or with a package.



# RETAINER PAYMENT & REFUND POLICIES



ALL bridal parties are required at the time of booking to pay a retainer fee to retain their desired time slot and date in which they wish to book.

- ALL BRIDES MUST PAY 50% OF THEIR PACKAGE PRICE OR LISTED RATE UPON BOOKING.
- BRIDESMAIDS, MOB/G AND ALL OTHER ATTENDEES must pay a \$40 per-person retainer fee.

This retainer will be credited to each person's services that day.

After the retainer has been made, an updated invoice will be sent to the email address on file and the remaining balance of services will be due anytime before or ON the date in which my services are being provided.

- ALL RETAINER PAYMENTS MADE ARE NON-REFUNDABLE AND NON-TRANSFERABLE - unless;
  - you have to cancel and re-book your wedding date and your NEW date is within the same calendar year.
  - Any re-booked dates outside of the calendar year in which your wedding has been booked will require a new deposit made.
  - If you need to cancel your wedding for any reason at all - retainer payments are still non-refundable - even if I am not available for your secondary date.

I understand that by signing this contract, I am responsible for full payment of any balances due for the bridal party on the date written in this contract in which services are to be provided by FLAWLYSS ARTISTRY LLC. I understand that no refunds will be given of any payments or deposits made unless otherwise stated.

If my wedding date is cancelled or rescheduled, I understand I must give provider, FLAWLYSS ARTIS LLC, a MINIMUM 90 day notice. If my wedding date is cancelled and I fail to give appropriate notice stated in this contract, I understand that I am responsible for paying FLAWLYSS ARTISTRY LLC all balances due.

I understand that I am responsible for any and all travel fees including the flat rate travel fee quoted to me, parking, hotel stay or air fare fees that are required during the contracted dates of booking, and any others discussed and included on this contract.

I understand that as the client, I am responsible for informing the makeup artist working on me of any allergies I may have to skincare or makeup ingredients. I release FLAWLYSS ARTISTRY LLC from any responsibility regarding any inflammation or rashes caused by the lack of information provided by the client about said allergies.
